RESULTS OF 2025 ANNUAL GENERAL MEETING

In accordance with ASX Listing Rule 3.13.2 and section 251AA of the *Corporations Act 2001* (Cth), the results of the Annual General Meeting (**AGM**) of The Star Entertainment Group Limited held on Tuesday, 25 November 2025 are set out below.

- Item 4: **Remuneration Report** resolution passed (95.47% For)
- Item 5: **Conditional Spill Resolution** As a 'second strike' was not received on the Company's 2025 Remuneration Report, votes on the Conditional Spill Resolution in Item 5 were disregarded.
